Summary of Sales Comparison Approach. All 3 comparables are from the subjects marketing area. Since the appraiser was unable to perform an interior inspection, the comparables were considered similar to the subject in condition. Also the FWA and Central A/C could not be verified for the subject, therefore no adjustments were noted. Greater weight to comparable 1 & 2 since the comparable 3 appeared to be similar in gross living area, and utility. Comparable 3 is situated in a similar neighborhood as the subject, and is smaller in gross living area. The larger lot for comparable 3 was adjusted at \$15 per sqft which was obtained by paired sales analylis.

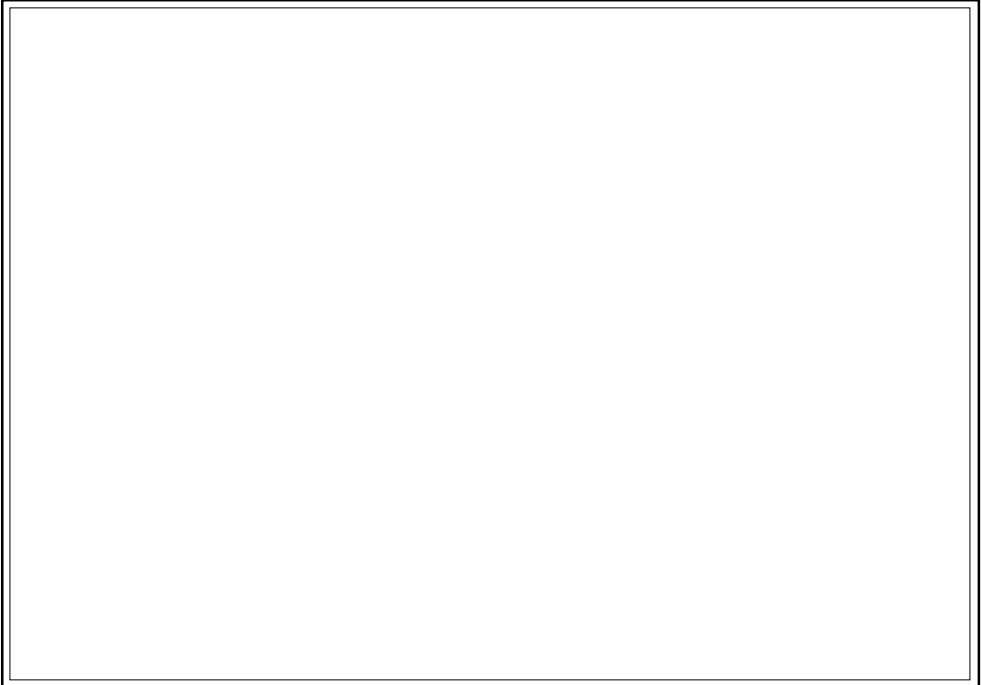

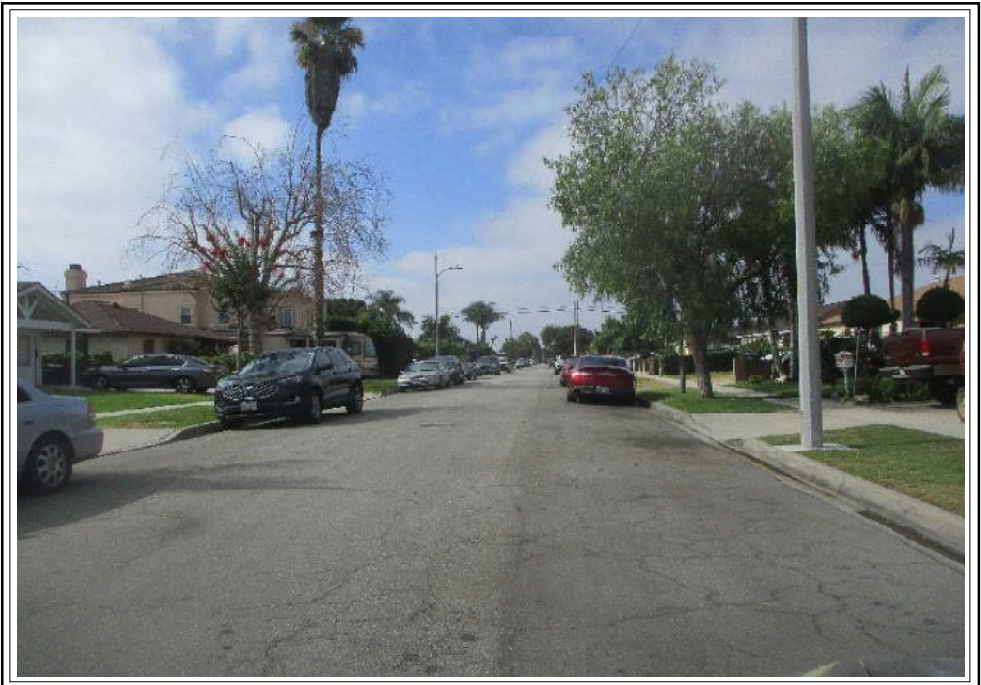


**FRONT VIEW OF

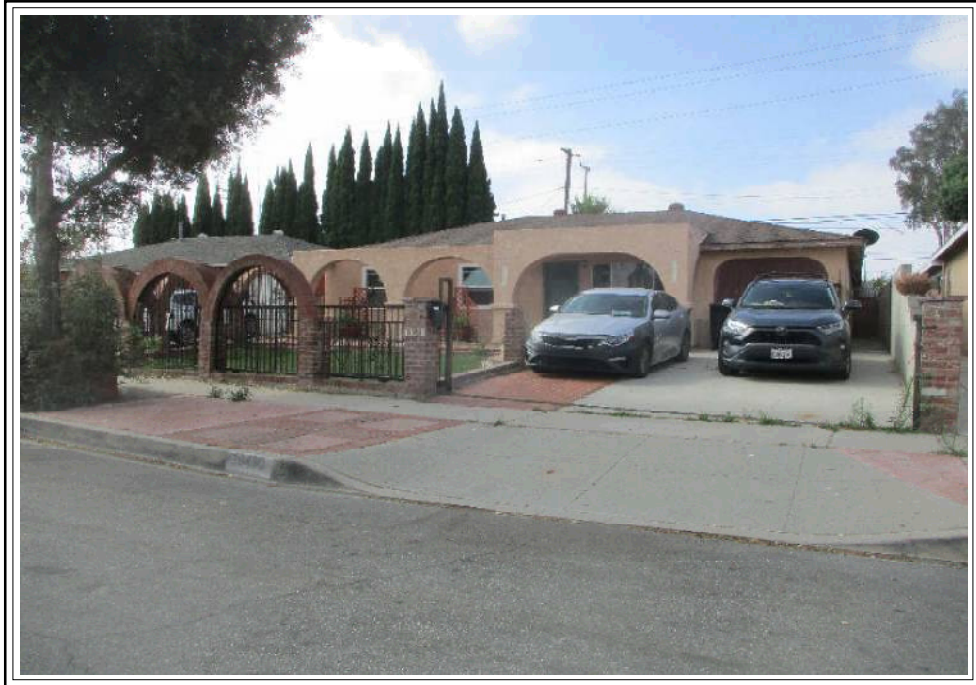

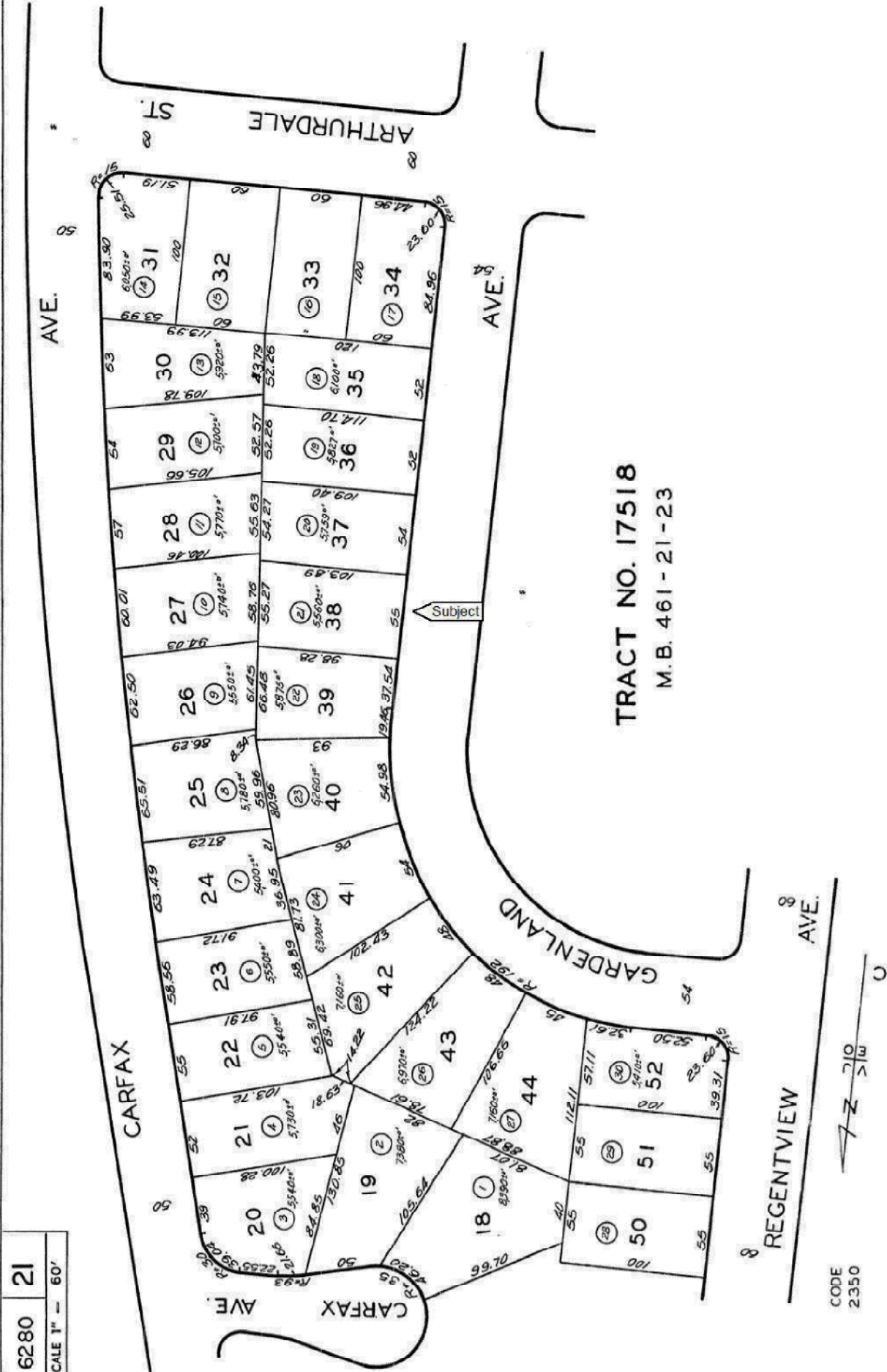

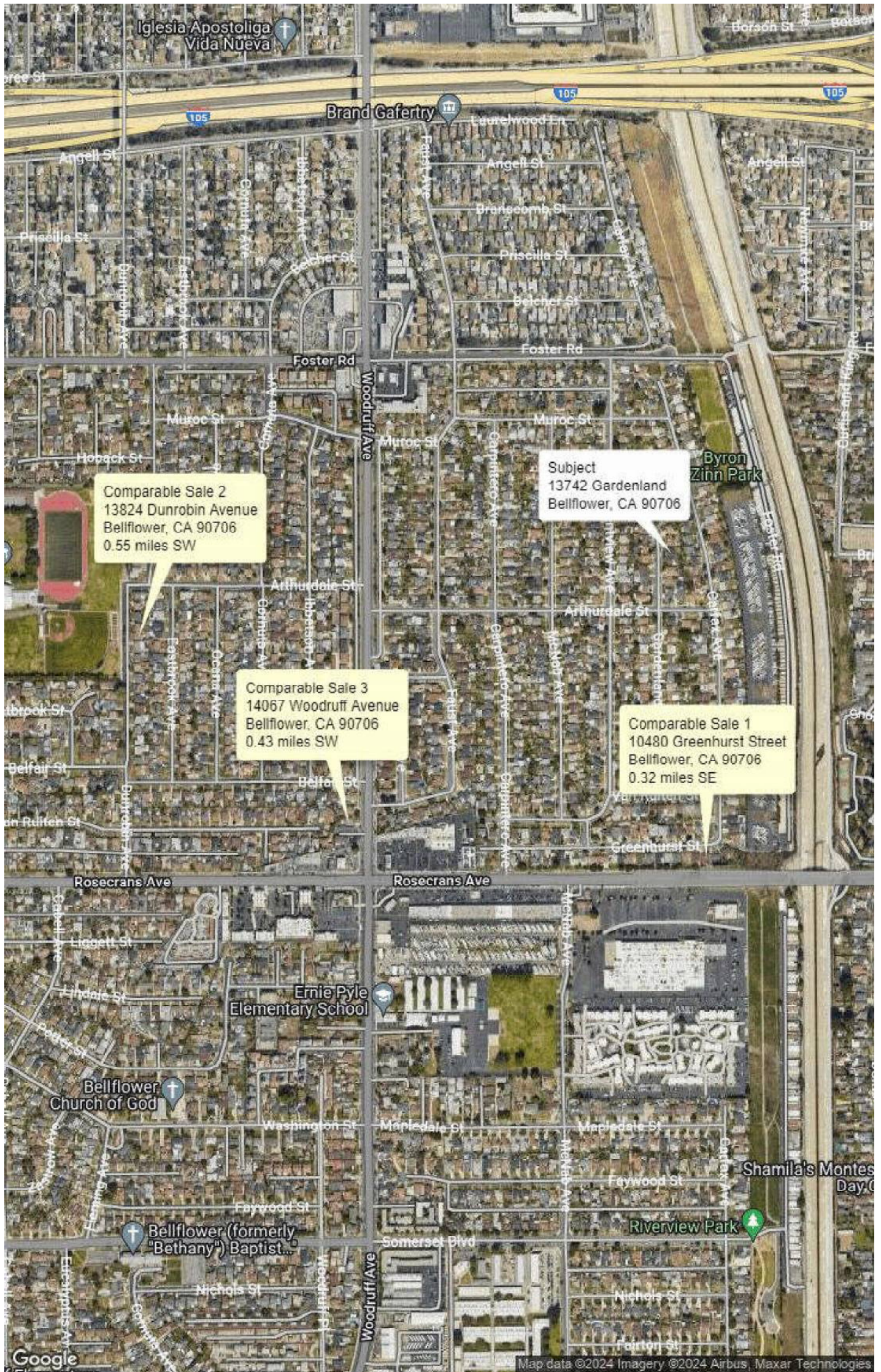
