Due to the lack of sales in the subject market it was necessary to expand search for comps in the GLA, style, lot size and bed, bath count tolerance. Due to limited active comps in the area, comp were used despite not bracketing the GLA as they are still considered to be reliable comparable. However, CS1 and LC1 held the most weight in the final analysis. Property values and appeal are not affected by the location to the Busy roads, park, water bodies, major roads and commercial centers.




